- 2) MUST BE 18 YRS OF AGE TO EXHIBIT A STALLION
- 3) CLASSES WITH LESS THAN 3 EXHIBITORS MAY BE COMBINED/ CANCELLED REFUNDS WILL BE CONSIDERED BY THE SHOW COMMITTEE, IF APPROVED REFUND CHECK WILL BE MAILED WITH IN 15 DAYS AFTER SHOW
- 4) ALL PRE ENTER MUST BE RECEIVED WITH PAYMENT OR OPEN CHECK, IF NOT THEY WILL BE SUBJECT TO POST ENTRY FEE.
- 5) RETURNED CHECK FOR ANY REASON MUST BE REPLACED WITH A MONEY ORDER OR CASHIERS CHECK PLUS A \$10.00 PENELTY FEE.
- 6) HARD HAT WITH HARNESS AND BOOTS ARE MANDATORY FOR ENGLISH
