Participation Agreement at the Jack Tharp Arena

I, the undersigned, agree as a condition of participation in any activity in this arena, to release save harmless, defend, protect, and indemnify any person and/ or organization (including but not limited to the Willits Frontier Days Association, the directors of any of those corporations, all committees and sponsors, their representatives and Successors) in any way associated therewith and their agents, members, officers, and directors from loss, damages Or liability of any sort arising out of or in any way relating to my participation in said Rodeo, Roping, Drill Team, Gymkhana, or Horse Show activity. If the participants is a minor the under signed parent or guardian acknowledges That they have read this agreement and agrees to be bound by its terms as a releaser and as a guarantor and Indemnitor of said persons and / or organizations and their agents, members, officers and director, for the minor and in the minor's place and stead. I waive ALL RIGHTS which I now or may have by virtue of Section 1542 of the California Civil Code which reads: "a general release does not extend to the claims which a creditor dose not know Or suspect to exist in his favor at the time of executing the release, which if know by him must have materially affected his settlement with the debtor."

I know the rodeo and any horseback riding activity can be potentially hazardous activity. I assume all risks associated with this event, including but not limited to falls, injury to myself, my child, or my horse, etc. Having read this waiver and knowing these facts and in consideration of your accepting my entry. I, for myself or for my child and anyone entitles to act on my behalf waive and release Willits Frontier Days Association, a California Non Profit Corporation the directors and all sponsors, their representatives and successors from all claim or liabilities of any kind arising out of participation or my child's participation in any horseback riding activity and rodeo even though that liability may arise out of negligence or carelessness on the part of the persons/ groups named in this waiver.
